The manufacturing unit is in Lusaka, comprising of Liquid orals and external preparations.

Our other Plant is International Drug Co Ltd (Sterile Products Division, Kabwe) is a Zambia's sole manufacturer of Intravenous fluids and it's located in Kabwe which 140 kms from Lusaka. This is our sterile product division where large volume Parenteral solutions are being manufactured. It was founded by the government in 1978, then known as General Pharmaceuticals Ltd and purchased by us on the 24th January 2001. This plant consists of class 100 clean rooms, microbiology laboratory, physicochemical laboratory and warehouse facilities.

This Plant was officially re-commissioned on 25 August 2002 by the late President of the Republic of Zambia, Levy Patrick Mwanawasa S.C.International Drug Company employs around 200 employees both in Lusaka and Kabwe.
